## 4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

### SMALL SPILLS

STEL (Short Term Exposure Limit) - the average airborne concentration over a 15 minute period which should not be exceeded at any time during a normal eight-hour workday.

Wear rubber boots, overalls, gloves, safety glasses, dust mask. Available information suggests that gloves made from nitrile rubber should be suitable for intermittent contact.
